

NATIONAL CONVENTION ON THE SPECIAL PROGRAM IN SPORTS (SPS)



To: Bureau Directors

1. The Department of Education (DepEd), through the Bureau of Secondary Education (BSE), announces the conduct of the **National Convention on the Special Program in Sports (SPS)** from November 11 to 13, 2014 at the Teachers Camp, Baguio City.
2. The Convention aims to:
 - a. update the SPS implementers on the program;
 - b. provide them with a venue to meet and learn from each other's experiences in the course of program implementation;
 - c. allow them to share their best practices; and
 - d. thresh out emerging issues and concerns.
3. The participants in this activity are regional and schools division sports supervisors, sports coordinators, and school heads of SPS schools/recipients of the financial subsidy and other schools implementing the SPS.
4. A registration fee of Three Thousand Five Hundred Pesos (P 3,500.00) shall be charged to each participant to cover board and lodging, supplies and materials, and other incidental expenses relative to the Convention. Registration fee and traveling expenses of participants shall be charged to the Maintenance and Other Operating Expenses (MOOE)/Special Education Fund (SEF)/local funds, while board and lodging and traveling expenses of resource persons and training staff and honoraria of resource persons shall be charged to BSE Funds, subject to the usual accounting and auditing rules and regulations.
5. The registration will start at 3:00 p.m. on **November 10, 2014** at the Romulo Hall. The first meal to be served will be dinner on **November 10** and the last meal will be afternoon snacks on **November 13, 2014**. Enclosed is the Schedule of Activities.
