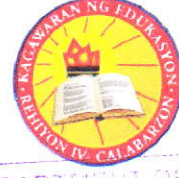

The National Disaster Response Plan (NDRP) for Earthquake and Tsunami, the Integrated Contingency Plan and OPLAN YAKAL, were prepared in collaboration with the different government agencies, civic and international humanitarian organizations through the leadership of the Office of Civil Defense (OCD) and guidance of the Department of Social Welfare and Development as Vice-Chairperson for Response based on the lessons from previous disasters that hit the Philippines.

On the other hand, most of the LGUs have their own operational plan and/or manual for disaster response. Hence, it is required to confirm the consistency between new-born NDRP and manuals or unwritten protocols of each organization. With the periodical executions of simulation exercises for disaster response based on the current and related plans and manuals are indispensable to effectively and efficiently sustain the NDRP.

In view thereof, the conduct of the 4<sup>th</sup> Quarter NSED is scheduled on 14 November 2014, 9:00AM, Friday at the ceremonial site in Quezon Memorial Circle, Diliman, Quezon City.

In this regard, you are hereby directed to spearhead the conduct of an Earthquake Drill in your respective offices and enhance the information dissemination on the forthcoming activity.

All IEC and advocacy activities should be documented and attached to the final report to be submitted to OCD through the Operations Division not later than 21 November 2014, for consolidation and submission to the Office of the President.
