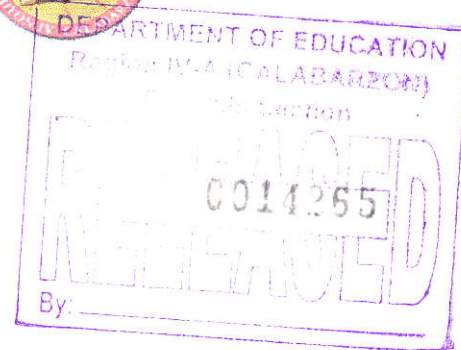




The Procuring Entity can download the form thru the PhilGEPS website (www.philgeps.gov.ph). The COC that could be generated online has two (2) types:

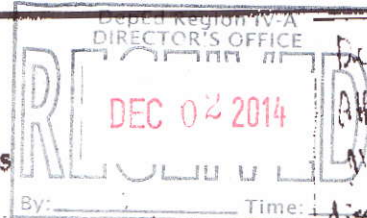
1. Certificate of Compliance with PhilGEPS Posting for agencies with posted opportunities with an Approved Budget for the Contract (ABC) of above Php 500,000.00; and
2. Certificate of No PhilGEPS Posting for agencies with no posted bid opportunities with an ABC of above Php 500,000.00.
