## REGIONAL TRAINING WORKSHOP ON CONTENT AND PEDAGOGY IN ARALING PANLIPUNAN

## To : SCHOOLS DIVISION SUPERINTENDENTS

- 1. In line with the Department's thrust for quality education, this Office through the Curriculum and Learning Management Division shall conduct Regional Training Workshop on Content and Pedagogy in Araling Panlipunan at GSP Training Center, Tagaytay City on October 29-31, 2014.
- 2. This activity aims to equip Araling Panlipunan teachers with the knowledge, skills and access to information that enable them to perform effectively. Teacher participants are expected to come up with a module dealing with the least mastered competencies based from the recent NAT results of Grades 3, 6, 8 and Fourth Year high school. Primarily, the module must contain concept, activities, strategies or techniques and assessment that can be used by Araling Panlipunan teachers in the field. The utilization of the materials would somehow help fellow teachers deliver the content and pedagogy better. In addition, the failure in the NAT would be addressed using this intervention.
- 3. Each division is expected to send participants as enumerated below:

Grade 3 teacher	1
Grade 6 teacher	1
Grade 8 teacher	1
Fourth Year teacher	1
Araling Panlipunan supervisor	1
Total	5 per division

4. The participants are enjoined to bring laptops and learning materials such as books, curriculum guides or PSSLC/PELC, teachers' guides, learners' materials and other references to be used in writing the modules. Using 4As Approach, each pair of teacher- participants for every grade or year level is expected to make one (1) module containing one (1) competency or objective,

at least two (2) activities, at least two (2) strategies or techniques and at least ten (10) -item question using HOTS for assessment. Traditional and authentic assessments in evaluating pupils/students outcome must be considered by the writers.

- 5. In order to come up with quality assured product, an editing committee composed of all division supervisors in Araling Panlipunan is enjoined to oversee and edit the modules written by writer participants.
- 6. The output is to be printed and soft copy will be distributed, as well.
- 7. There will be no registration fee but traveling and other expenses relative to the training are charged against local funds subject to the usual accounting and auditing rules and regulations.
