SUBJECT: Submission of Justification for Low Enlistment Percentage and an Updated Status Report of Personnel Enlistment to Preferred Service Providers for the PhilHealth Primary Care Benefit 1 (PCB1) Package

DATE: 17 February 2015

In line with Department Memorandum No. 30, s. 2014 issued last 12 March 2014 with the subject *Expansion of PhilHealth Primary Care Benefit 1 (PCB 1) Package to Cover Personnel of the Department of Education*, orientations on PCB 1 implementation were conducted in different regions from September to November 2014. Issues raised by the participants during the orientation are now being addressed by the TWG and Executive Committee.

As reiterated in these orientations, it is expected that all schools have already submitted the masterlist of teaching and non-teaching personnel's preferred service providers to the Division Office for onward submission to the Local Health Insurance Office (LHIO) in their respective areas. After submission of the aforementioned data, DepEd personnel must personally go to their assigned (chosen) service provider for enlistment. (Schools may coordinate with the service providers for proper scheduling of teachers' enlistment.) It must be emphasized that only enlisted personnel can avail of the PCB 1 services, which may only be availed from their assigned service provider.

The processes of assignment and enlistment of personnel to their preferred service providers were expected to be completed (100%) by the end of June 2014. Unfortunately, based on PhilHealth's status report as of December 2014, only 33.2% (139,473) had enlisted.

In this connection, all Regional Directors are instructed to submit a report explaining the low enlistment percentage along with an updated enlistment status (following the attached template) to the DepEd Central Office – Health and Nutrition Center (HNC) through e-mail address hnc.health@yahoo.com or fax number 632 9935 on or before 26 February 2015.

All Regional Directors and Schools Division Superintendents are directed to give utmost priority to the PCB1 project so that all DepEd teaching and non-teaching personnel may already avail of the PCB 1 services as soon as possible.

Attached are the enlistment status by region (Annex A), the template to be used for the report (Annex B), and the PCB 1 flowchart (Annex C) for ready reference and dissemination.

Immediate attention and strict compliance to this Memorandum are desired.

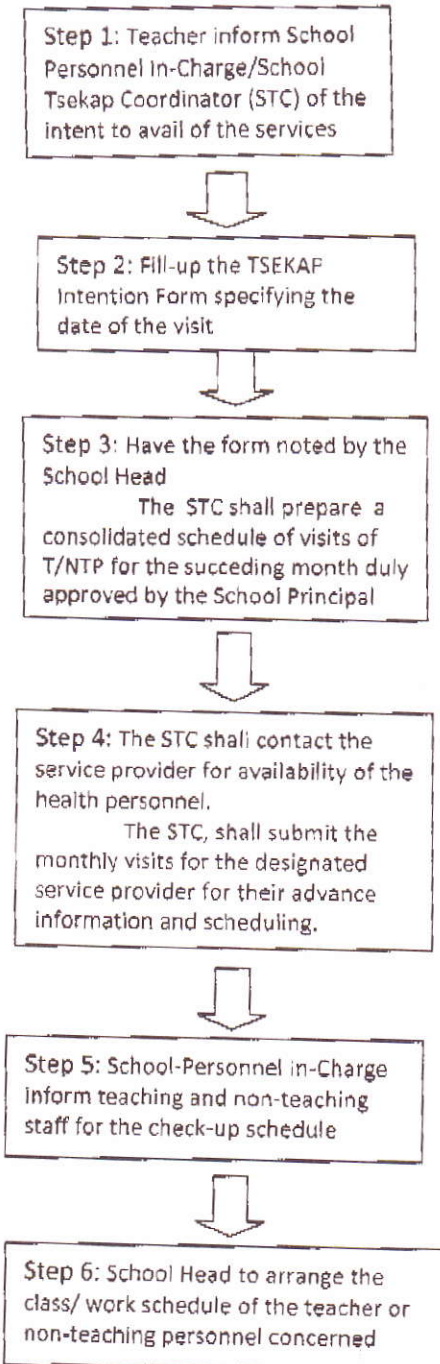
