**CREATION OF THE MANAGEMENT SUPPORT COMMITTEE (MSC)  
FOR BAGUIO TEACHERS CAMP (BTC)**

1. Pursuant to Presidential Proclamation No. 290 dated July 18, 1988, Baguio Teachers' Camp (BTC) is a prime real estate property of the Department of Education (DepEd) located in Baguio City. For the past 106 years, BTC has been recognized as a national treasure known for its worthy venue for conferences and a rest and recreation destination of public and private teachers and guests. It is a primary provider of opportunities for professional growth and development for all teaching, non-teaching and administrative support staff.

2. BTC's average annual gross income (FY 2010 to FY 2013) from the rentals for the use of BTCs' dormitories, cottages and other facilities is P30.79M. Meanwhile, its average annual occupancy is 182, 428 individuals for the same period.

3. Such being the case, there is an imperative need to fully sustain BTC as a viable source of income to finance its operations. There are also other internal and external operational issues, problems and concerns which are either unresolved and/or recurring thereby affecting its smooth operations and resulting in situations requiring the attention and support of higher management in the DepEd for proper, prompt and timely handling and disposition.

4. In view of this, the Department of Education (DepEd) hereby creates a **Management Support Committee (MSC)** with the following compositions:

Chairman	:	Undersecretary for Curriculum and Instruction
Co-Chairman	:	Undersecretary for Legal and Legislative Affairs
Members	:	Undersecretary for Finance and Administration Assistant Secretary for Finance and Administration Director, Administrative Service Director, Public Affairs Service Chief Accountant, DepEd Central Office Camp Superintendent, Baguio Teachers Camp
Secretariat	:	Office of the Director, Administrative Service

5. The MSC shall be responsible to provide necessary advisory and policy-making assistance to BTC and it shall perform the following functions:
- a. Recommend policies which will effectively improve the administration and management of BTC;
  - b. Provide advisory assistance in addressing problems and/or disputes concerning the ownership of BTC by DepEd; and
  - c. Ensure effective implementation of recommended and approved actions and activities relating to the operations of BTC.
6. Immediate dissemination of and strict compliance with this Order is directed.
