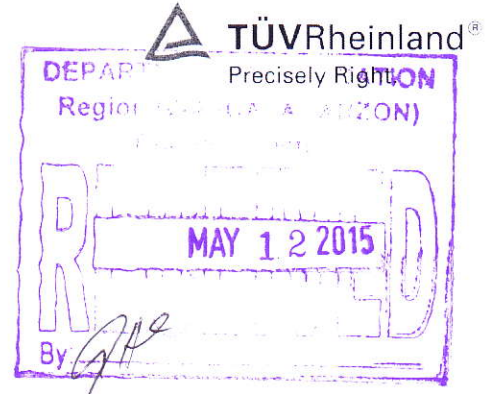

The seminar workshop will be of most value to **school heads, directors/directresses, principals, academic administrators, subject area coordinators** and **high school teachers** in **private education institutions**.



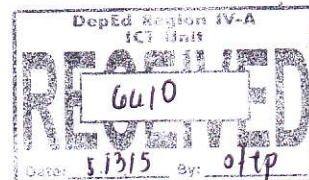
