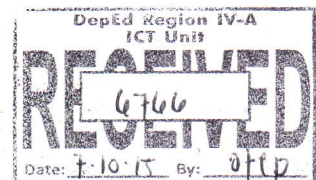

RDC RESOLUTION NO. IV-A-46-2015

“APPROVING THE CONDUCT OF THE SEARCH FOR OUTSTANDING GENDER AND DEVELOPMENT IMPLEMENTER”

WHEREAS, the Regional Development Council Sub-Committee on Gender and Development (RDC SCGAD) is mandated to orchestrate gender mainstreaming and promote localization of Magna Carta of Women in various initiatives in the region;

WHEREAS, the RDC SCGAD deemed it necessary to provide incentives and awards system at the regional level to outstanding regional line agencies, local government units and state universities and colleges to further promote gender mainstreaming and strengthen the Gender and Development (GAD) Focal Point Systems in the region;

WHEREAS, the RDC SCGAD developed the Search for Outstanding GAD Implementer guidelines based on the GAD Impala awards at the national level developed by the Philippine Commission on Women;

WHEREAS, the Search will utilize the five entry points of gender mainstreaming and nominees will be evaluated using the following entry points: a) policies (15 points); b) people (25 points); c) enabling mechanisms (25 points); d) programs, projects and activities (25 points); and e) replication (10 points);

WHEREAS, during its second quarter meeting on 14 May 2015 the Sectoral Committee on Macroeconomy and Development Administration endorsed the approval of the conduct of the Search;

NOW THEREFORE, on motion duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to approve the conduct of the Search for Outstanding GAD Implementer;
