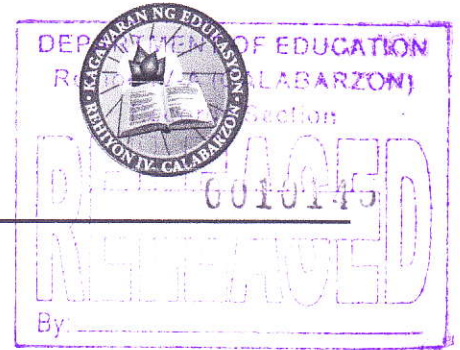

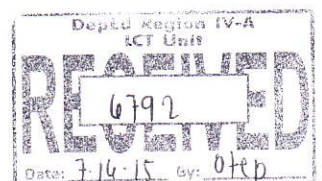
The activity aims to:

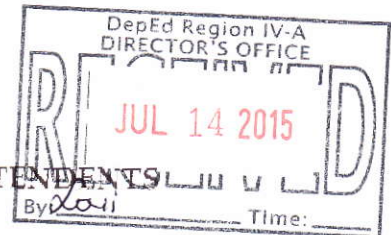
