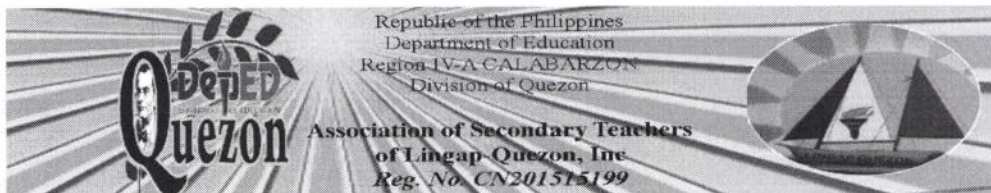

Greeting of Peace!



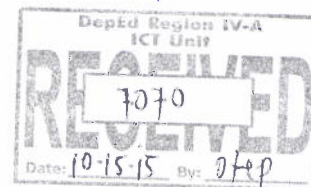
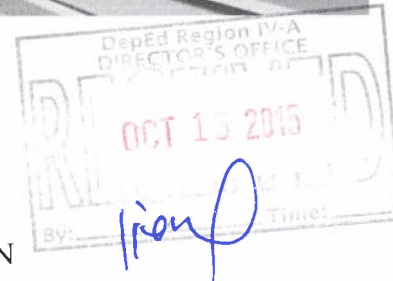
