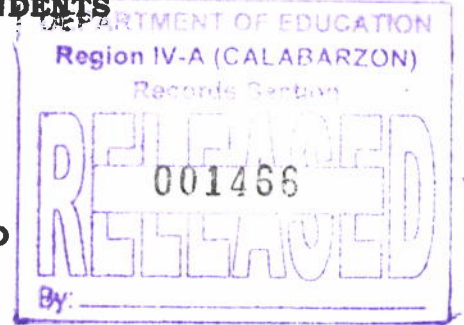

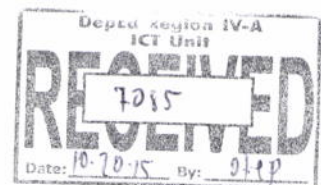


Also, we would like to continue the conduct of another joint meeting next month, October, to discuss program updates with representatives from the Division offices. This will pave for the discussion of the following:
