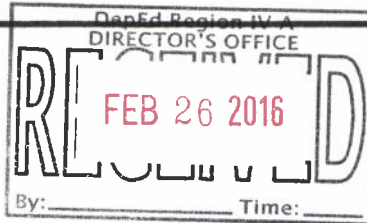

SUBJECT: Approval of the Creation of Head Teacher I Positions for  
School Year (SY) 2016

DATE: February 18, 2016

We are pleased to inform you that the Department of Budget and Management (DBM) has granted the authority for the creation of SEVENTEEN THOUSAND SIX HUNDRED (17,600) new Teacher I positions for Kindergarten to Grade 10, SY 2016-2017. Consistent with the DBM's existing procedures, the DBM Regional Offices (ROs) will issue the Notice of Organization, Staffing and Compensation Action (NOSCA) directly to the Implementing Units (IUs) based on the deployment report we have submitted.

Note that the electronic copies of the deployment report by school was already communicated by the Planning and Programming Division, Planning Service to all the Regional Offices on February 12, 2016. As mentioned, the deployment report should remain 'as is' (as approved by DBM), i.e. no changes/realignments shall be made.

Consistent with our current policies in the hiring of teachers; whether pertaining to previous or newly created positions, priority shall be given to qualified contractual, Kinder Volunteer Teachers (KVTs) or Local Government Unit funded (LGU-funded) teachers with a proviso that they meet the selection criteria and included in the Registry of Qualified Applicants (RQA).

Please be reminded that the new appointees should report to the school not earlier than May 15, 2016. Thus, it is assumed that by this time the recruitment, evaluation and selection process had already been commenced following strictly the guidelines stipulated in DepEd Order no. 7 and 22 s. 2015.

Finally, the profile and assignment of teachers hired and deployed based on the set allocation shall be sent via e-mail to the Planning and Programming Division, Planning Service through [ps.ppd@deped.gov.ph](mailto:ps.ppd@deped.gov.ph) copy furnished [zaida.briones@deped.gov.ph](mailto:zaida.briones@deped.gov.ph) using the attached template. The report shall be submitted not later than June 30, 2016
