



The next Automated National and Local Election in the country is set to take place on May 9, 2016 and preparations in ensuring an honest and worry free elections undertaken by the various involved organizations are underway. Meralco, as a member of the Department of Energy (DOE) led 2016 Power Task Force on Elections (PTFE), would like to contribute to the success of the elections by providing reliable electric service on Election Day. A copy of the DOE Department Circular Number DC2016-01-001 defining our role in this election is attached herewith for your reference (Attachment 1).

As part of our mandate, we have inspected all schools that will serve as Polling Centers in our franchise area and results of these inspections as well as recommended actions for some schools (with findings that need corrective action — Attachment 2) were relayed to the School Principals and/or Teacher-In-Charge for their reference and action (Attachment 3). In light of this, we are humbly requesting the Honorable Secretary to issue a reminder to all concerned to attend to the said findings and recommendations.

May we also solicit your help in communicating the following messages to ensure that a continuous electric supply is maintained on Election Day:

- 1. Avoiding the use of high consuming electric appliances and gadgets like percolators, coffee maker, air coolers, etc. that could overload the electric service of your school
- 2. Unlisting the service of a highly qualified and license electricians to check the wiring and protective device of your classrooms that will serve as polling centers.
- 3. Ensuring presence of school maintenance personnel or electrician on standby during Election Day to attend to any trouble that may arise.
