



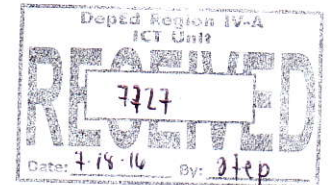

SUBJECT : EXTENSION OF DENG VAXIA VACCINATION PERIOD AND SUBSEQUENT CHANGES IN DEWORMING FOR JULY 2016

DATE : July 14, 2016

Relative to the request of the Department of Health Regional Office IV-A to extend the Dengue vaccination of target Grade 4 students SY 2015-2016 (currently Grade 5 SY 2016-2017) until July 29, 2016, this Office concurs with the request and hereby requests the full cooperation of all concerned Divisions and Schools.

Furthermore, please be guided of the following changes in DepEd Regional Memorandum 212 s. 2016 "Clarification on Deworming Guidelines for July 2016" uploaded July 8, 2016:

1. Deworming of the Target population **except for Grade 5 recipients** will be done on July 2016. Last day of deworming would be on July 28, 2016 (Thursday).
2. The **Grade 5 recipients will be dewormed 4 weeks after their vaccination** to allow the prescribed observation period for adverse events.
3. Initial Text reporting of deworming accomplishment by the Division Coordinators (*excluding Grade 5*) to Regional Coordinator at 0917 811 0690 is due on **August 1, 2016 (Monday)** by 3 PM following this format:
Division Elementary/# enrolled/# dewormed; Division High School/# enrolled/#dewormed
Example: Antipolo Elementary/20,000/15,000; Antipolo High School/15,000/7,500
4. Final Report by the Division Coordinators (*including Grade 5*) to Regional Coordinator at ess_calabarzon@yahoo.com and pearloliveth@yahoo.com is due **on September 15, 2016 (Thursday)** by 3 pm *instead of August 8, 2016* using the attached excel format. Please email the excel file and also a scanned document illustrating the signatories.
