Warm Greetings of Solidarity from ACT-Region IV-A!

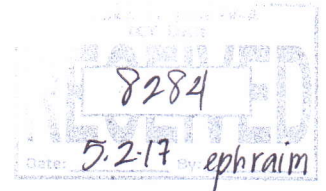
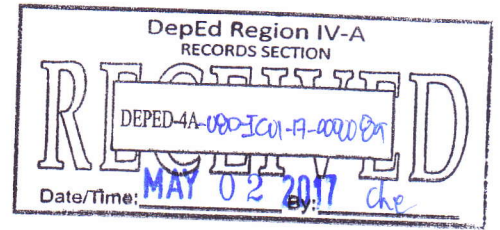
The Alliance of Concerned Teachers-Region IV-A Union has been granted with a Certificate or registration as the Teachers' Union representing the teaching personnel in **CALABARZON**. The **Certificate of Registration no. 1946** was granted on November 07, 2014 by **Department of Labor and Employment (DOLE)** and **Civil Service Commission (CSC)**.

The formation of unions of public employees, of which public school teaching personnel is a part of, is granted by laws such as the Magna Carta for Public School Teachers (RA 4670), the Guidelines for the Exercise of the Right to Organize Government Employees (EO 180 s. 1987). This is in consonance with the **DepEd Order No. 51 series of 2003**, entitled, "**Teacher Orientation to Public Unionism**". This mandates that *all public school teachers and non-teaching personnel must be provided with relevant and adequate information on the legal basis of public sector unionism* and that **all principals and school superintendents shall allow teachers** and even non-teaching personnel to participate in any public employee's organization-sponsored seminar. It is also correlated with **DepEd Memorandum 209, s. 2011** - Dissemination of Public Sector Labor-Management Council (PSLMC) Resolution (Registration and Accreditation of Public Elementary and High School Teaching Personnel Organizations of the Department Of Education)
