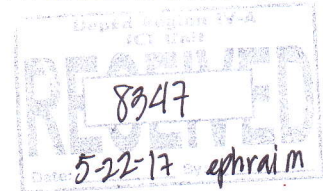

- Present the activities and interventions to be used in the training.



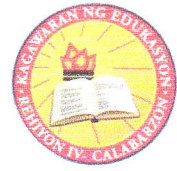
