To address the various issues and challenges the RO and SDO encounter relative to the processes involved in the Operations of Public and Private Schools, this Office through the Quality Assurance Division will conduct Capability Building cum Workshop with its partners from Schools Division Offices on November 23-24, 2017 at a venue to be announced later.

The enabling objectives of this activity are for the participants to:

1. revisit the existing processes and policies relative to Operations of Private Schools and Establishment of Public Schools including Senior HSs;
2. share experiences, issues and challenges encountered and own practices relative to Operations of Private Schools and Establishment of Public Schools including Senior HSs; and
3. develop mechanisms to expedite the identified processes.
