I. BACKGROUND INFORMATION

The National Union of Career Executive Service Officers (NUCESO), in partnership with the Career Executive Service Board (CESB) will conduct the **17th Annual Career Executive (CES) Conference on 14-16 November 2018** at the **SMX Convention Center, Davao City** with the theme, "*Serbisyong Totoo sa Tunay na Pagbabago Para sa Mamamayang Pilipino*".

Participants to this event are all Career Executive Service Officers (CESOs), Career Executive Service Eligibles (CESEs), Career Service Executive Eligibles (CSEEs) holding Career Executive Service (CES) positions and CESOs and CESEs holding Non-CES positions nationwide.

One of the biggest delegations to the event will be the Philippine Educators Association of CESOs and Eligibles (PEACE), Inc. composed of all DepEd CESOs from the Central, Regional and Schools Division Offices, Career Executive Service (CES) and Career Service Executive (CSE) Eligibles, and other DepEd officers holding third level positions.

Since the Office of the President issued Memorandum Circular (MC) No. 48, dated 8 October 2018, authorizing participation in the said conference on official business, PEACE, Inc. once again decided to conduct its **6th PEACE, Inc. General Assembly** a day before the said Annual CES Conference, **13 November 2018**.

II. STATEMENT OF REQUEST
