We are pleased to inform Your Honors that the **Philippine Educators' Association of Career Executive Service Officers (CESOs) and Eligibles (PEACE), Inc.** will hold its **Sixth (6<sup>th</sup>) General Assembly** with the theme, "*DepEd CESO: Tapat na Serbisyo para sa Tunay na Progreso at Pagbabago*" on 13 November 2018, from 9:00 am to 6:00 pm, in Davao City (exact venue to be announced).

Participants in this activity are members of the PEACE, Inc. Executive Board and Regional Representatives, Regional Directors, Assistant Regional Directors, Schools Division Superintendents, Assistant Schools Division Superintendents, CES Eligibles, CES-WE Passers, and other PEACE, Inc. members nationwide.
