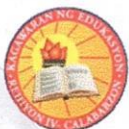
**FUNDING REQUIREMENT FOR SCHOOLS DIVISION OFFICES FOR THE PROVISION OF

To Schools Division Superintendents

1. With reference to Joint Memorandum No. DM-OUCI-2020-358 dated November 23, 2020, Supplementary Guidelines in the Utilization of Downloaded Funds for Provision of Learning Resources in the implementation of BE-LCP, the Regional Office Finance Division provides the status of funding requirement listed below:

2. Please be informed that the Quarter 4 funding deficiency amounting to **₱21,642,982.00** shall be chargeable to FY 2021 allocation for MOOE of Elementary, JHS, SHS or subject to representation to Local School Board/SEF, see attached breakdown for reference.
3. The use of the funds shall be subject to the existing government budgeting, accounting and auditing rules and regulations.
4. All Schools Division Offices finance personnel shall be required to submit Statement of Expenditures (Annex 1) prescribed in DO No. 18, s. 2020 duly certified by the SDO Accountant and approved by the Schools Division Superintendent.
