**CONTEST MECHANICS
CREATIVE PAINTING COMPETITION**

1. Background and Objectives

In celebration of the 79th Araw ng Kagitingan and Philippine Veterans Week, the Department of Education, Philippine Veterans Affairs Office and the Department of National Defense are sponsoring a Creative Painting Contest in the National Level.

The contest objectives are to increase awareness of historical places in the Philippines during world War II where Veterans fought for the country and sacrificed lives, and to remember the reasons why we experience freedom up to this day.

2. Participants

The contest is open to Grades 4, 5 or 6 pupil enrolled in any public and private elementary schools nationwide. The school should be duly recognized by the Department of Education.

3. Scope/Theme

The entries should depict the life, works and heroism of our Filipino heroes who fought for our country and should be in line with this year's theme: "KAGITINGAN AY GAWING GABAY, PANDEMYA AY MAPAGTATAGUMPAYAN."

4. Entry Specification

Only entries submitted in correct and complete specifications and formats will be considered official. Please take note of the following requirements to ensure that the entry satisfies the specifications of the contest:

4.1 The painting should be in a 15" X 20" illustration board.

4.2 Contestant may use any medium of their choice.

4.3 The painting must be described in one or two sentences. The description must be typewritten and printed on a 1/2 A4 bond paper and posted at the back of the entry together with the following information:

4.3.1 Name of Learner

4.3.2 Contact Number

4.3.3 Name of School

4.3.4 School Address

4.3.5 Division

4.4 The Philippine Flag should not be used as background of the painting. If used as part, it should be placed in a conspicuous place to show its importance to the artwork (please refer to Sec.39-Prohibited Acts under Republic Act (RA) No. 8491 titled "An Act Prescribing the Code of the National Flag, Anthem, Motto, coat-of-Arms and Other Heraldic Items and Devices of the Philippines."

The contestants shall record their activity during the painting of their “obra maestra” through video with 360 degrees horizontal and vertical with clear and focus in different angles, provided that the delivery and action of the contestant will not be affected.

7.Determination and Announcement of Winners

The Entry which will get the highest score shall be declared as the Regional Champion and who will be also as the representative to the National Level, the with second highest score shall be declared as the first runner- up and the entry with third highest score shall be declared as the second runner -up.

Announcement of winners will be done through Regional memorandum.

8.Submission of Entries

8.1 The deadline for the submission of entries will be on April 19, 2021 at 5:00PM

8.2 Each entry must be accompanied by the following requirements:

8.2.1 A certification from the principal/OIC that the contestant is enrolled in the current School Year (2020-2021).

8.2.2 Scanned image of the pupil registration form or ID, Principal's /OIC ID , and accomplished entry form (Enclosure 1a).

8.3 Entries shall be submitted to Mr. Leonardo C. Cargullo (Leonardo.cargullo@deped.gov.ph) address to RD Francis Cesar B. Bringas through ESSD Chief Eduarda M. Zapanta. Once the painting is available, a clear video with any musical background while working on the painting can be included depending upon the desire of the contestant, and clear pictures with the names of the contestant , teacher coach, principal/OIC ,PSDS, Division Special Events Coordinator, Schools Division Superintendent and LGU (Optional).

9.Awards

Winners (first to third) for this year competition may receive certificate of Recognition and appreciation while all the participants will receive certificate of participation.

10. Copyright

The organizer DepEd Region IV-A have the right to publish the entries and own the painting.

11.The decision of the Board of Judges is final and irrevocable.

CONTEST MECHANICS ORATORICAL CONTEST

1.Participants

The contest is open to Grades 7, 8,9 or 10 students enrolled in any public and private secondary schools nationwide. The school should be duly recognized by the Department of Education.

2.Theme and Content

The oratorical piece must be in Filipino, original, never been published, and expounding on the theme: " KAGITINGAN AY GAWING GABAY, PANDEMYA AY MAPAGTATAGUMPAYAN."

The piece must be delivered for a minimum of seven (7) minutes and a maximum of ten (10) minutes.

The oration **MUST NOT**, in whole or in part, expressly or impliedly offend any race, religious freedom, nor should it be against the laws of environment, honor and dignity, or the moral standards of Filipinos.

The Entry which will get the highest score shall be declared as the Regional Champion and who will be also as the representative to the National Level, the with second highest score shall be declared as the first runner- up and the entry with third highest score shall be declared as the second runner -up.
