**SUBMISSION OF REPORTS FOR THE ONLINE PROCESS IMPLEMENTATION REVIEW ON THE
USE OF KLE, LDM, AND WHLP FOR HOME-BASED LEARNING**

To **Schools Division Superintendents**

1. In response to the directives of the Office of the Undersecretary for Curriculum and Instruction, through the Bureau of Learning Delivery-Teaching and Learning Division (BLD-TLD), to consolidate reports for the Process Implementation Review on the Use of Kindergarten Learning Experience (KLE), Locally Developed Materials (LDM), and Weekly Home Learning Plan (WHLP) for Home-Based Learning, this Office announces that all SDOs shall submit the aforesaid report on April 16, 2021.
2. This activity aims to:
 - a. identify the key initiatives/practices and outcomes of the utilization of KLE, LDM, and WHLP;
 - b. determine the extent of the utilization of KLE, LDM, and WHLP in home-based learning;
 - c. note the gaps and challenges encountered in utilizing KLE, LDM, and WHLP;
 - d. trace the progress of the implementation of KLE, LDM, and WHLP;
 - e. write a report on the interventions/remediation in the implementation of Kindergarten Learning at home including assessment; and
 - f. conceptualize plans or future directions of home-based Kindergarten learning.
3. Persons involved in this activity are Education Program Supervisors/Division Coordinators in-charge of Kindergarten in Region IV-A CALABARZON.
4. Education Program Supervisors/Division Coordinators in-charge of Kindergarten shall use the template given by the Region (see Enclosure 1). Soft copy of the template can be accessed in the shared folder given to the persons involved via Google Drive. Moreover, the files shall be saved as *Word file* with the filename format **PIR_SDO-Name_Kinder_20-21** (e.g. PIR_SDO-Quezon_Kinder_20-21).
5. The report shall be uploaded in the aforesaid shared folder via Google Drive by using the link sent to the Education Program Supervisors/Division Coordinators
