**2021 PRIVATE SCHOOLS SUMMIT**

To **Schools Division Superintendents**  
**Presidents, Division Private Schools Associations**  
**Private Schools Administrators**

1. In line with the DepEd Region IV-A CALABARZON's objectives of institutionalizing and continuously improving a quality assurance system in the regulation of private schools' operations amidst Covid-19 pandemic, this Office through Quality Assurance Division will host the **2021 Virtual Summit of Private Schools** with theme "**Facing the Challenges of the New Normal and Building Enhanced Partnership Mechanisms on Basic Processes with Private Schools**".
