Schools Division Superintendents**

1. DepEd CALABARZON strongly supports the Sustainable Development Goal (SDG) 5 which aims to achieve gender equality and empower all women and children. This reflects in the gender and development initiatives of the region through the HRDD in collaboration with the Regional GAD FPS. To further advance the mainstreaming efforts of the region, there shall be a CB Program for Regional and Division GAD Learning Facilitators on May 24-26, 2021 via an online platform.
2. The training aims to create a pool of learning facilitators on GAD to advance the gender mainstreaming efforts of the region. Specifically, the training aims the participants to:
