1. Pursuant to DepEd Order No. 23, s. 2020 entitled **OPERATIONAL GUIDELINES ON THE IMPLEMENTATION OF THE SCHOOL-BASED FEEDING PROGRAM FOR SCHOOL YEAR 2020-2021**, the Regional Office through the Education Support Services Division in coordination with the Department of Local and Interior Government (DILG) Region IV-A has issued a Memorandum regarding the DepEd CALABARZON's request for assistance in the distribution of milk and nutritious food products in areas under localized lockdown and in cases where Enhanced Community Quarantine and Modified Enhanced Community Quarantine were declared.
