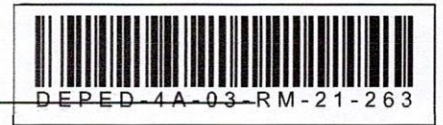

**DOH CALABARZON VIRTUAL TRAINING ON INFANT AND YOUNG CHILD FEEDING IN EMERGENCIES (IYCF-E)**

To **Schools Division Superintendents**

1. The Department of Health Center for Health Development CALABARZON in coordination with the Department of Education Region IV-A CALABARZON will be conducting a **VIRTUAL TRAINING ON INFANT AND YOUNG CHILD FEEDING IN EMERGENCIES (IYCF-E)** on June 24-25, 9:00 AM via Zoom.
2. This virtual training aims to capacitate the Nutrition stakeholders on Infant and Young Child Feeding in Emergencies. This focuses on emergency preparedness, response, and recovery to minimize infant and young child morbidity and mortality risks associated with feeding practices and to maximize child nutrition, health, and development.
3. The participants to this activity are Division Medical Officers, Division School-Based Feeding Program Coordinators, and selected School DRRM Coordinators.
4. The School DRRM representatives shall be coming from schools frequently used as evacuation centers, either from elementary or secondary schools.
