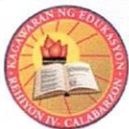

**Regional Memorandum**

**IDENTIFICATION OF SCHOOL BASED FEEDING PROGRAM BENEFICIARIES  
FOR SY 2021-2022**

To **Schools Division Superintendents**

1. In line with the implementation of the **SCHOOL-BASED FEEDING PROGRAM** for SY 2021-2022, this office through the Education Support Services Division informs the field on the beneficiaries of the abovementioned program for the SY 2021-2022.
2. The Primary Beneficiaries are as follows:
  - a. All Kindergarten enrollees for SY 2021-2022.
  - b. All Grades 1-5 beneficiaries of SBFP during SY 2020-2021 which were promoted to Grade 2-6 for SY 2021-2022.
  - c. All Grade 1 enrollees for SY 2021-2022 which are members of 4Ps and included in "LisTahanan" by Department of Social Welfare and Development (DSWD).
  - d. All Grade 1 enrollees for SY 2021-2022 identified by their parents as undernourished (Wasted and Severely Wasted) and reported to their respective Advisers.
3. For identification of Severely Wasted and Wasted Grade 1 enrollees, Grade 1 advisers are requested to inform the parents or guardians to have their children weighed in their respective homes. In cases where there are no available resources such as weighing scale and height measurement tool, the parents can be advised to go their nearest Health Centers for weight and height measurement in accordance with the IATF Guidelines and must strictly observe the minimum health protocols.
4. The following data must be submitted to the advisers to identify the Nutritional Status of Grade 1 enrollees:
  - Height (in meters)
  - Weight (in kilograms)

5. In identifying the Nutritional Status of Grade 1 enrollees, School Form 8 or the Nutritional Status Report Form by Grade Level can be used. School Form 8 (SF8) shall only be used for determining the Nutritional Status of Grade 1 enrollees and not mandatory for updating in the LIS facility as per DepEd Memorandum 14, s. 2021 entitled Interim Guidelines on the Preparation, Submission, and Checking of School Forms for the School Year 2020-2021.
  6. In case of exceeded Grade 1 beneficiaries versus the target, the SW and W Grade 1 learners shall be prioritized.
  7. In addition, it is strongly advised that the SDOs shall provide comprehensive orientations with the Grade 1 Advisers in determining beneficiaries from Grade 1 enrollees.
