

UNDERSTANDING AND UTILIZING MEDIA IN TEACHING (UUMT) CONCEPT PAPER

I. PROGRAM OVERVIEW

The National Council for Children's Television (NCCT), created under Republic Act No. 8370 or known as the "Children's Television Act of 1997", is an attached agency of the Department of Education (DepEd). NCCT is primarily mandated to promote and encourage the production and broadcast of child-friendly television programs to develop the children's knowledge, skills, and a strong sense of national identity as a Filipino.

NCCT provides free media education to children, parents and guardians, and educators through Media Literacy Orientation Services (MLOS) as part of its general functions. MLOS aims to equip them with the necessary skills to critically assess, evaluate, and create media content. One of its flagship projects is "Understanding and Utilizing Media in Teaching (UUMT) — a Seminar-Workshop on Media Literacy Integration in the K to 12 Curriculum," a three-day seminar-workshop designed for Basic Education Teachers. It is designed for Basic Education Teachers to enable them to integrate Media Literacy across various subject areas.

The MLOS was originally designed for face-to-face activities, but due to the restrictions imposed by the COVID-19 pandemic, it will be shifted to an online learning system.

II. PROGRAM OBJECTIVES

At the end of the UUMT seminar-workshop, the participants will familiarize themselves with the key concepts of media literacy and utilize their skills in analyzing and evaluating media content in the integration of media literacy across subject areas. Specifically, the seminarworkshop aims to:

- 1) Recognize the role that media play in the students' learning environment;
- Evaluate media texts using the Media Literacy Concepts;
- 3) Utilize the Child-Friendly Television Content Standards in evaluating media content;
- 4) Examine possible ways of integrating Media Literacy across various subject areas;
- 5) Develop a distance learning plan with Media Literacy Integration; and
- 6) Demonstrate a lesson with Media Literacy Integration.

III. PROGRAM OUTLINE

The UUMT will be conducted on a virtual setup. It has five modules that will be discussed for three days. A week before the actual training facilitation, a Technical Run will be administered. Asynchronous tasks will be assigned to the participants every after



synchronous meetings. On the last day, the session will commence in the afternoon as its morning will be dedicated for brainstorming of the groups for their Distance Learning Plan output.

The Output of the UUMT workshop is a Distance Learning Plan – a lesson plan document of
