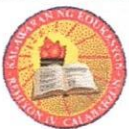

CLMD4A BUDGET OF WORK (BOW)

To **Schools Division Superintendents**

1. This Office, through the Curriculum and Learning Management Division (CLMD), issues the **CLMD4A Budget of Work (BOW)**.
2. This resource material, with reference to DepEd Order No. 21, s. 2019 on *Policy Guidelines on the K to 12 Basic Education Program* and all other existing DepEd issuances on curriculum management, provides explanation and details on how these most essential learning competencies (MELC) and enabling competencies are budgeted and distributed in each quarter.
3. This material includes the budget of work for all learning areas and/or programs. Enclosure 1 presents the complete CLMD4A Budget of Work (BOW).
4. The Bureau of Curriculum Development introduced and released the MELCs which can be taught using TV and/or radio platforms. These learning competencies have already been incorporated in the CLMD4A BOW as guide for teachers and other curriculum managers.
5. All public school teachers in the region are enjoined to follow the designed CLMD4A BOW in teaching all the target MELCs and LCs as prescribed by the K to 12 Basic Education Curriculum. This shall also be used in designing learning resources, such Self-Learning Materials (SLMs), Learner's Packet (LeaP), Learning Activity Sheets(LAS).
6. All curriculum managers such as Education Program Supervisors (EPSs), Public Schools District Supervisors (PSDSs) and School Heads are expected to peruse the attached guidelines for proper monitoring and evaluation in the implementation of this curricular project under the Region IV-A CALABARZON PIVOT to Quality Basic Education (PIVOT 4A QuBE) Program.
