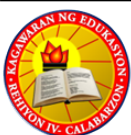

**HARMONIZATION OF SYSTEM PROCESSES CUM ORIENTATION ON SYSTEM AND
POLICY UPDATES RELATIVE TO LIS & EBEIS FOR SY 2021-2022**

1. To ensure continued access to learning opportunities amidst the continuing national public health emergency brought by the COVID-19 pandemic, the department issued DepEd Order No. 32, s. 2021 which provided schools range of options in implementing the enhanced enrollment procedures that are efficient, safe, and conforming with the minimum health and safety standards.
