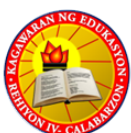

11. Liquidated damages equivalent to one tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. the amount of the contract, without prejudice to other courses of action and remedies open to it.
