2. The **additional technical specifications** of the above-mentioned project is as follows:

Each of the security guards to be assigned by the **SECURITY COMPANY** in the **REGIONAL OFFICE's** premises must be:

- a. Of good moral character and reputation, courteous, alert and without criminal or police record;
 - b. Physically and mentally fit;
 - c. Not less than twenty (21) years of age nor more than 40 years of age;
 - d. Duly Licensed and properly screened and cleared by the Philippine National Police, National Bureau of Investigation, and other Government Offices issuing clearance for employment with ancillary goods and equipment;
 - e. In proper uniform and with other security paraphernalia such as high-powered flashlight and night stick.
 - f. In possession of such other qualifications required by Republic Act No. 5847 as amended by Presidential Decree Number 11, 100 and 1919; and
 - g. Must have passed the Neuro-psychiatric exam.
3.
