BAC RESOLUTION DECLARING ASEA METRICS HR SOLUTIONS, INC. AS THE SINGLE HIGHEST RATED BIDDER (SHRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF CONSULTANCY SERVICES FOR THE DEVELOPMENT OF ONLINE SYSTEM FOR THE FY 2021 NQESH ADMINISTRATION AND MANAGEMENT

WHEREAS, on October 8, 2021, DepEd Regional Office IV-A CALABARZON through its Bids and Awards Committee (BAC) posted the Request of Expression of Interest (REI) for the Procurement of **CONSULTANCY SERVICES FOR THE DEVELOPMENT OF ONLINE SYSTEM FOR THE FY 2021 NQESH ADMINISTRATION AND MANAGEMENT** in the PhilGEPS website, office website and in a conspicuous bulletin board of the office;

WHEREAS, the Approved Budget for the Contract (ABC) is **SIX MILLION EIGHT HUNDRED NINETY ONE THOUSAND PESOS (PHP6,891,000.00)**;

WHEREAS, three (3) bidders participated but only the following bidders were shortlisted:

Bidder	Rating	Remarks
Asea Metrics HR Solutions, Inc	89.16	Pass
Assessment Analytics	71.83	Pass

WHEREAS, the Competitive Bidding Procedures for Consulting Services, using the Quality-Cost Based Evaluation (QCBE) procedure pursuant to Republic Act No. 9184 (RA 9184) and its Implementing Rules and Regulations (IRR) were adopted in evaluating the bids of the two (2) shortlisted bidders;

WHEREAS, upon evaluation of the criteria and corresponding numerical weights, **ASEA METRICS HR SOLUTIONS, INC.** obtained a total score of **94.169**, while Assessment Analytics obtained a total score of **53.96**. The passing score/rate as indicated in the TOR and REI is seventy-percent (70%). The evaluation and rating is hereto attached as **Annex "A"** and forms part of this resolution;

WHEREAS, on November 4, 2021, the BAC issued approved BAC Resolution No. BR01-21-185 recommending **ASEA METRICS HR SOLUTIONS, INC.** as the Single Highest Rated Bidder (SHRB). A copy of approved BAC Resolution No. BR01-21-185 is hereto attached, marked as **Annex "B"** and made an integral part hereof;

WHEREAS, a Notice to **ASEA METRICS HR SOLUTIONS, INC.**, as the Single Rated Bidder was issued and post-qualification was thereafter conducted;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **ASEA METRICS HR SOLUTIONS, INC.**, the BAC found the company compliant and responsive. A copy of the Post Qualification Report is hereto attached, marked as **Annex "C"**, and is made an integral part hereof;



2. To **RECOMMEND APPROVAL** by the Head of Procuring Entity the foregoing findings.


