BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE WORKSHOP ON PUBLIC SERVICE CONTINUITY PLANNING FOR REGIONAL OFFICE TO CIUDAD CHRISTHIA RESORT INC.

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **WORKSHOP ON PUBLIC SERVICE CONTINUITY PLANNING FOR REGIONAL OFFICE ON MARCH 8-10, 2022**;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED TWENTY THOUSAND PESOS (Php128,000.00)**;

WHEREAS, Rule XVI, Section 48.2 of the IRR of RA 9184 provides the general rule that public bidding is the general mode of procurement. However, the same section allows procuring entities to resort to alternative methods of procurement such as Negotiated Procurement subject to the approval of the Head of Procuring Entity;

WHEREAS, Rule XVI, Section 53.9 of the IRR of RA 9184 allows Negotiated Procurement under Small Value Procurement as a mode of procurement subject to the approval of the Head of Procuring Entity;

WHEREAS, the Request for Quotation (RFQ) was posted at the PhilGEPs website, office website and conspicuous bulletin board of the regional office on February 28, 2022;

WHEREAS, RFQs were sent to at least three prospective suppliers;

WHEREAS, Two (2) Suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
