BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF SECURITY GUARD SERVICES AT NEAP-MALVAR, BATANGAS TO KINGS 2000 SECURITY SERVICES CORP.

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **SECURITY GUARD SERVICES AT NEAP-MALVAR, BATANGAS FOR THE PERIOD COVERED APRIL 1, 2022 TO APRIL 31, 2023**;

WHEREAS, the Approved Budget for the Contract (ABC) is **EIGHT HUNDRED SEVENTY THOUSAND TWO HUNDRED SIXTY ONE PESOS AND 12/100 (Php870,261.12.00)**;

WHEREAS, Rule XVI, Section 48.2 of the IRR of RA 9184 provides the general rule that public bidding is the general mode of procurement. However, the same section allows procuring entities to resort to alternative methods of procurement such as Negotiated Procurement subject to the approval of the Head of Procuring Entity;

WHEREAS, Rule XVI, Section 53.9 of the IRR of RA 9184 allows Negotiated Procurement under Small Value Procurement as a mode of procurement subject to the approval of the Head of Procuring Entity;

WHEREAS, the Request for Quotation (RFQ) was posted at the PhilGEPS website, office website and conspicuous bulletin board of the regional office on March 22, 2022;

WHEREAS, RFQs were sent to at least three prospective suppliers;

WHEREAS, four (4) Suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
