GUIDELINES ON THE CONDUCT DIVISION PARENT-TEACHER ASSOCIATION (PTA) FORUMS FOR SY 2022

To Schools Division Superintendents

- 1. This is in connection to **DepEd Order No. 013 s. 2022** dated March 18, 2022, concerning the Omnibus Guidelines on the Regulation of Operations of Parent-Teacher Associations (PTA's) with the purpose and specific objectives clearly stipulated.
- 2. The Nationwide PTA Forum was conducted by the External Partnership Service (EPS) DepEd Central Office via Zoom and live-streamed in DepEd Philippines last April 19, 2022 participated by ESSD Chiefs, Regional and Division Partnership Focal Persons, and selected Federated PTA Presidents for clarity of the issued guidelines.
- 3. The provisions found in relevant issuances concerning the implementation of these guidelines are given emphasis for reference which are as follows:
 - DepEd Order No. 54 s. 2009 Revised Guidelines Governing Parent-Teacher Associations (PTAs) at the School Level
 - Section 8.3 Submission of Financial Report
 - Section 9.0 Prohibited activities
 - Section 9.5 Cancellation of PTA Recognition.
 - DO 77, s. 2009 Guidelines for the Conduct of Elections of the Parent-Teacher Associations (PTAs) at the School Level and their Federations.
 - DO 83, S. 2010 Amendments to DepEd Order No. 77, s. 2009
 "Guidelines for the conduct of elections of the Parent-Teacher Associations (PTA's) at the school level and their Federations."
- 4. Relative to this, Chiefs of School Governance and Operations Division (SGOD) and the Head, Legal Office of SDO's are advised to conduct the Division Orientation on the Omnibus Guidelines and assist school heads in the conduct of PTA Fora to discuss and clarify the guidelines. This activity must be properly documented.
- It is underscored that all DepEd Orders, memoranda, rules and regulations which are inconsistent with this Order are repealed, rescinded or modified accordingly.
