RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE REVIEW AND VALIDATION OF ALS RESOURCES EXEMPLARS-LEARNING STRAND 1, 2 AND 3 FOR THE BASIC LITERARY PROGRAM (BLP) ELEMENTARY AND SECONDARY LEVELS TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **REVIEW AND VALIDATION OF ALS RESOURCES EXEMPLARS-LEARNING STRAND 1, 2 AND 3 FOR THE BASIC LITERARY PROGRAM (BLP) ELEMENTARY AND SECONDARY LEVELS ON MAY 2-6, 2022;**

WHEREAS, the Approved Budget for the Contract (ABC) is **THREE HUNDRED THOUSAND PESOS (Php300,000.00);**

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office starting on April 12, 2022 to April 20, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to at least three (3) prospective suppliers;

WHEREAS, one (1) Supplier submitted its proposal; **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount of **TWO HUNDRED NINETY EIGHT THOUSAND FIVE HUNDRED PESOS (Php298,500.00)**. Thus, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCR);
