## BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE DESIGNING AND DEVELOPMENT OF LEARNING RESOURCE PACKAGE FOR PROFICIENT TEACHERS (TI-TIII) AND SUPERVISORS PROFESSIONAL DEVELOPMENT PROGRAMS TO THE BAYLEAF CAVITE

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the DESIGNING AND DEVELOPMENT OF LEARNING RESOURCE PACKAGE FOR PROFICIENT TEACHERS (TI-TIII) AND SUPERVISORS PROFESSIONAL DEVELOPMENT PROGRAMS ON APRIL 25-30, 2022;

WHEREAS, the Approved Budget for the Contract (ABC) is FOUR HUNDRED TWENTY THOUSAND PESOS (Php420,000.00);

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office starting on April 11, 2022 to April 18, 2022 at 9:00 a.m.

**WHEREAS**, RFQs were sent to at least three(3) prospective suppliers;

**WHEREAS**, two (2) Suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
