BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE WORKSHOP ON THE DEVELOPMENT OF LEARNING ASSURANCE FOR MONITORING AND PROGRESS (LAMP) FOR YEAR-END ASSESSMENT PHASE 1 & 2 TO TAGAYTAY AUTO MART, INC.- TAGAYTAY COUNTRY HOTEL

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **WORKSHOP ON THE DEVELOPMENT OF LEARNING ASSURANCE FOR MONITORING AND PROGRESS (LAMP) FOR YEAR-END ASSESSMENT PHASE 1 & 2 ON MARCH 22-25, 2022**;

WHEREAS, the Approved Budget for the Contract (ABC) is **FIVE HUNDRED SIXTY THOUSAND PESOS (Php560,000.00)**;

WHEREAS, Rule XVI, Section 48.2 of the IRR of RA 9184 provides the general rule that public bidding is the general mode of procurement. However, the same section allows procuring entities to resort to alternative methods of procurement such as Negotiated Procurement subject to the approval of the Head of Procuring Entity;

WHEREAS, Rule XVI, Section 53.9 of the IRR of RA 9184 allows Negotiated Procurement under Small Value Procurement as a mode of procurement subject to the approval of the Head of Procuring Entity;

WHEREAS, the Request for Quotation (RFQ) was posted at the PhilGEPS website, office website and conspicuous bulletin board of the regional office on March 10, 2022;

WHEREAS, RFQs were sent to at least three prospective suppliers;

WHEREAS, one (1) Supplier submitted its proposal; **TAGAYTAY AUTO MART, INC.-TAGAYTAY COUNTRY HOTEL** in the amount of **FIVE HUNDRED FORTY SIX THOUSAND PESOS (Php546,000.00)**. Thus, **TAGAYTAY AUTO MART, INC.-TAGAYTAY COUNTRY HOTEL** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **TAGAYTAY AUTO MART, INC.-TAGAYTAY COUNTRY HOTEL** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);






