PARTICIPATION TO THE PHILIPPINE YOUTH CONVERGENCE 2022

To **Schools Division Superintendents**

1. Pursuant to DepEd Memorandum entitled Philippine Youth Convergence 2022 dated May 10, 2022, the Office of the Assistant Secretary for Youth Affairs and Special Concerns (OASYASC) will conduct the **Philippine Youth Convergence (PYC) 2022** from June 14 to 17, 2022 in Puerto Princesa City, Palawan.
2. The PYC 2022 aims to reassess, realign, and refocus its youth-related initiatives to be more responsive.
3. On Item No. 4 of the Memorandum, Schools Division Superintendents will identify and nominate (seven (7) students and two (2) PDO-YFC/Teacher-Adviser based on the criteria in Enclosure 1 and submit to the Regional Office the fully accomplished Pre-Registration Form duly signed on or before May 27, 2022
4. All participants must be fully vaccinated. Other details of the participants can be found in Enclosure No. 1 and 2.
5. Participants shall undergo Antigen Testing chargeable against local funds subject to the usual accounting and auditing rules and regulations. Participants may also opt for antigen testing in their respective LGUs.
6. The CALABARZON delegates shall wear the DepEd Youth Formation CALABARZON Polo Shirt on Day 1, procurement of the polo shirts shall be charged against the YFD funds in the Regional Office.
7. The SDOs are requested to provide vehicle to the participants to and from the airport. The PDO I shall take charge of the coordination and request for vehicle in their respective SDO.
8. Expenses for the board and lodging of selected participants and Youth Formation Coordinators (YFC) shall be charged to YFD Funds of Central

Office. Travel expenses and other incidental expenses of the other participants shall be charged to local funds or any available school funds subject to the usual accounting and auditing rules and regulations.
