PARTICIPATION TO THE NATIONAL INVITATIONAL SPORTS COMPETITION

To Schools Division Superintendents

1. With reference to Memorandum dated April 12, 2022 issued by the Office of Atty. Revsee A. Escobedo, Undersecretary, Field Operations, Palarong Pambansa Secretariat and DEACO regarding the Composition of Various Management Working Committees and Technical Officiating Officials of the Seven Sports and Additional Information on the Conduct of the National Invitational Sports Competition (NISC), this Office announces the participation of DepEd Region IV-A CALABARZON to the National Invitational Sports Competition on the following dates and venues:

- 2. All concerned are enjoined to provide the necessary support and assistance to the participating student-athletes, including DepEd personnel who will serve as coaches, chaperon, technical officials (referee, judges, umpire), trainers and members of the various technical working committees (see Enclosure 1).
- 3. DepEd personnel who will serve as technical officiating officials and perform game-related administrative work shall secure an official travel authority. Proof of vaccination such as vaccination cards or DOH-issued vaccination certificates and a medical certificate must be presented upon registration. Their travel expenses shall be charged against the 2022 Physical Fitness and School Sports Fund subject to the usual accounting and auditing rules and regulations while meals, accommodation, supplemental allowance, and other related expenses shall be shouldered by the host DepEd Division Offices.
- 4. Delegates and identified DepEd personnel shall report to the official venue one (1) day prior to the commencement of the competition. Below is the general schedule of activities of the NISC for reference:

Travel expenses of coaches, chaperons, and student-athletes shall be charged against local funds or other available sources (e.g. SEF, MOOE for Public School Participants, Private Sponsors if any) while meals, accommodation, supplemental allowance, and other related expenses shall be shouldered by the host DepEd Division Offices. On the other hand, all expenses to be incurred by the members of various technical working committees shall be charged against local funds or other available sources (e.g. SEF, MOOE for Public School Participants, Private Sponsors if any).
- 6. Travel expenses of Regional Officials shall be charged against Regional Funds while Schools Division Superintendents, Asst. Schools Division Superintendents, Division Sports Officers and identified trainers in Athletics who intend to provide moral support to their athletes in the said competition shall secure an official travel authority. Expenses relative to their travel shall be charged against local funds or other available sources (e.g. SEF, Private Sponsors if any).
- 7. Schools Division Offices are advised to assist the private school participants in securing funding from their respective Local School Board (LSB).
- 8. All relevant travel expenses to be incurred in this activity are subject to the usual accounting and auditing rules and regulations.
