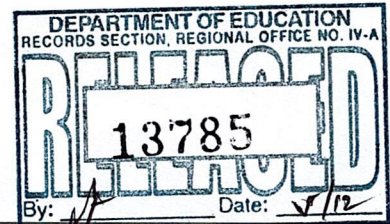

To **Schools Division Superintendents**

In reference to DepEd Order No. 44, s. 2015, Guidelines on the Enhanced School Improvement Planning (SIP) Process and the School Report Card (SRC), RA 9155, Governance of Basic Education Act of 2001, DepEd Order No. 12, s. 2020, DepEd Basic Education Learning Continuity Plan in the Time of COVID-19, and Republic Act No. 10533, Enhanced Basic Education Act of 2013, this office will be guided with the timeline below to ensure that all Schools Division Offices will be on the right track in the development of the Division Education Development Plan (DEDP) and School Improvement Plan (SIP) and to ensure its alignment to the Regional Education Development Plan (REDP).


