VALIDATION OF PARTICIPATING SCHOOLS IN THE CASE STUDY ON THE DELIVERY OF TECHNICAL ASSISTANCE TOWARDS THE TURNAROUND SCHOOL INITIATIVE PROGRAM OF DEPED 4A CALABARZON THROUGH SCHOOL-BASED MANAGEMENT

- To Schools Division Superintendents of Rizal Province, Antipolo City, Batangas Province, Cavite Province, Quezon Province and Laguna Province
- 1. Pursuant to DO 83, s. 2012, DO 44, s. 2016 and RM 281, s. 2022, this Office, through the Field Technical Assistance Division, will conduct validation of participating schools in the Case Study on the Delivery of Technical Assistance for the Turnaround School Initiative Program (TSIP) of DEPED 4A CALABARZON through School-Based Management (SBM).
- 2. Relative to this, the research team will validate the participating schools from the five (5) clusters in CALABARZON based on quality, access, and efficiency of schools and will select one (1) school from each cluster that will undergo institutional makeover through redesigning school-based management. - 3. The case study under the TSIP aims to provide research-based evidences as inputs in developing more relevant and responsive guidelines in the delivery of technical assistance to turnaround public schools in the region as well as to extend technical support and guidance to schools toward effective SBM implementation.

In view of this, the SDOs are requested to create a composite team composed of five (5) members who will serve as technical assistance providers, and overseers, and coordinate with the FTAD in the entire duration of the program. The participating schools are requested to prepare their performance indicators for the past five years, School Improvement Plans, and Annual Implementation Plans.
