1. This office disseminates the master list of schools in all sectors which successfully complied with the DepEd-DOH Joint Memorandum Circular (JMC) No. 1, s. 2022, DO 017, s. 2022 and RM 316, s. 2022, and are eligible to participate in the progressive expansion of face-to-face classes under alert levels 1 and 2 risk classification for school year 2021-2022 and succeeding school years.
2. The regional office through the Policy, Planning and Research Division (PPRD) shall issue Safety Seal for Basic Education and Certificate of Compliance to all eligible schools and reflect the status in the master list. These documents shall affirm that these schools comply with the minimum public health standards in the delivery of basic education services.
3. The master list of schools can be accessed through the link **bit.ly/CALABARZON-F2F-Schools**.
4. This master list shall be regularly updated by the PPRD in collaboration with the Quality Assurance Division (QAD) every Friday of the week based on the submitted reports by the persons-in-charge of face-to-face classes weekly reporting in all schools division offices per RM 118, s. 2022.
5. Schools Division Offices are advised to expedite the evaluation and validation of the compliance of the remaining school-nominees and to submit recommendations thereafter pertaining to the implementation of the face-to-face classes.


