RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE EVALUATION OF THE 7TH CYCLE BASIC EDUCATION RESEARCH FUND (BERF) RESEARCH PROPOSALS TO GREAT EASTER HOTEL

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the EVALUATION OF THE 7TH CYCLE BASIC EDUCATION RESEARCH FUND (BERF) RESEARCH PROPOSALS ON JULY 6-8, 2022;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED TWENTY THOUSAND PESOS (Php120,000.00);
