RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE WORKSHOP ON THE FINALIZATION OF ALS LEARNING RESOURCES EXEMPLARS FOR LEARNING STRAND 1, 2 AND 3 FOR BASIC LITERACY PROGRAM (BLP), ELEMENTARY AND SECONDARY LEVELS TO GREAT EASTERN HOTEL, INC.

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **WORKSHOP ON THE FINALIZATION OF ALS LEARNING RESOURCES EXEMPLARS FOR LEARNING STRAND 1, 2 AND 3 FOR BASIC LITERACY PROGRAM (BLP), ELEMENTARY AND SECONDARY LEVELS ON JULY 4-8, 2022;**

WHEREAS, the Approved Budget for the Contract (ABC) is **SIX HUNDRED FORTY THOUSAND PESOS (Php640,000.00);**

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise know as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office starting on June 15, 2022 to June 20, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to at least three (3) prospective suppliers;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:

WHEREAS, after review and deliberation on the proposal, **GREAT EASTERN HOTEL, INC.** complied with the requirements and declared as the Lowest Calculated and Responsive Bid (LCRB);




