BAC RESOLUTION

RECOMMENDATION TO AWARD THE CONTRACT TO NATIONAL PRINTING OFFICE (NPO) FOR THE PRINTING AND DELIVERY OF QUARTER 4 SELF-LEARNING MODULES (SLMS) FOR SY 2021-2022

WHEREAS, the Department of Education (DepEd) is mandated to deliver quality basic education and to make education accessible to all Filipino learners pursuant to Republic Act No. 9155¹ and to establish, maintain, and support a complete, adequate, and integrated system of education relevant to the needs of the Filipino learners pursuant to Republic Act No. 10533²;

WHEREAS, DepEd is unwavering in its commitment to provide quality basic education amidst the existing and emerging challenges brought about by the COVID-19 pandemic and, in this light, developed the Basic Education Learning Continuity Plan (BE-LCP) for School Year 2021-2022 to ensure uninterrupted services to the Filipino learners;

WHEREAS, among the learning modalities sanctioned under the BE-LCP of the DepEd is the use of printed self-learning modules as basic, if not primary, resource in distance learning;

WHEREAS, DepEd Region IV-A CALABARZON intends to procure services for the printing and delivery of Quarter 4 Self-Learning Modules (SLMs) for SY 2021-2022;

WHEREAS, the Approved Budget for the Contract is **NINETY THREE MILLION ONE HUNDRED SEVENTY EIGHT THOUSAND TWO HUNDRED NINETY NINE PESOS (Php93,178,299.00)**;

WHEREAS, on March 25, 2022, the Bids and Awards Committee (BAC) issued Resolution No. BR01-22-68, recommending to the Head of the Procuring Entity (HoPE) the approval of Negotiated Procurement under Agency-to-Agency Agreement. The HoPE approved said recommendation;

WHEREAS, on March 28, 2022, the BAC sent Request for Quotations (RFQs) to APO Production Unit, Inc. (APO), National Printing Office (NPO) and Bangko Sentral ng Pilipinas (BSP) requesting to submit their quotations on said project;

WHEREAS, on March 28, 2022, the Request for Quotations (RFQs) was also posted at the office website and conspicuous bulletin board in the premises of this Office;

WHEREAS, the abovementioned offices submitted their respective quotation, however, BSP replied that their production capacity is dedicated for the production of banknotes and judicial forms, thus:
