## BAC RESOLUTION

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE CALIBRATION OF INDIVIDUAL PERFORMANCE COMMITMENT REVIEW FORM (IPCRF) FOR ADMINISTRATIVE SERVICES DIVISION PERSONNEL TO THE FIRST VILLA CRISTINA HOTEL & RESORT INC.**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **CALIBRATION OF INDIVIDUAL PERFORMANCE COMMITMENT REVIEW FORM (IPCRF) FOR ADMINISTRATIVE SERVICES DIVISION PERSONNEL ON JUNE 21-23, 2022;**

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED FIFTY SIX THOUSAND PESOS (Php156,000.00);**

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office starting on June 3, 2022 to June 8, 2022 at 9:00 a.m.

**WHEREAS**, RFQs were sent to at least three(3) prospective suppliers;

**WHEREAS**, two (2) Suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:

**WHEREAS**, on June 15, 2022, the end-user conducted an ocular inspection at **FEMAR GARDEN RESORT AND CONVENTION CENTER;**

**WHEREAS**, based on their ocular inspection, the following were observed:


1. The rooms and function halls were not aesthetically cleaned or pleasing to the eyes;
2. The access from the main entrance to the hotel lobby is through a steep staircase which some of the participants may find difficult;
3. The stair rails are sticky, while the tables and chairs are soaking wet containing perceptible moisture that needs to be washed and cleaned;
4. One of the function rooms near the activity's designated function room is being renovated. Thus, the noise will affect the sessions/activities to be conducted; and
5. The place is not conducive to the needs of the participants.

**WHEREAS**, upon evaluation or careful examination of the documents and the ocular report submitted by the end-user, the BAC found that **FEMAR GARDEN RESORT AND CONVENTION CENTER** quotation is not responsive based on the above reasons stated;


**WHEREAS**, after review and deliberation on the proposal, **THE FIRST VILLA CRISTINA HOTEL & RESORT INC.** complied with the requirements and declared as the Lowest Calculated and Responsive Bid (SCRB);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **THE FIRST VILLA CRISTINA HOTEL & RESORT INC.** in the amount of **ONE HUNDRED FORTY EIGHT THOUSAND TWO HUNDRED PESOS (Php148,200.00)**.
