RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF CATERING SERVICES FOR THE NOTICE OF MEETING – DPR IQAT TO GOD’S TREASURE ENTERPRISES

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **NOTICE OF MEETING – DPR IQAT ON JUNE 29, 2022**;

WHEREAS, the Approved Budget for the Contract (ABC) is **FIFTEEN THOUSAND SIX HUNDRED PESOS (Php15,600.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on June 15, 2022 to June 20, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to at least three(3) prospective suppliers;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:

ROSHER’S CATERING SERVICES	Php15,600.00

WHEREAS, after review and deliberation on the proposal, **GOD’S TREASURE ENTERPRISES** complied with the requirements and declared as the Lowest Calculated and Responsive Bid (LCRB);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GOD’S TREASURE ENTERPRISES** in the amount of **FIFTEEN THOUSAND FOUR HUNDRED SEVENTY PESOS (Php15,470.00)**.


