**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **CONDUCT OF CPROCIA: COACHING PROGRAM FOR REGIONAL OFFICE CONTINUOUS IMPROVEMENT (CI) ADVOCATES SESSION 6 & 7 ON JULY 19-20, 2022;**

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:




